

1. Increase of the SSMU Club Fund Fee

Motion Regarding SSMU Club Fund Fee Referendum Question 2020-02-27

Do you agree to an increase of the opt-outable SSMU Club Fund Fee from \$2.75 to \$3.57, per semester, for all full and part-time SSMU members, to start in Fall 2020 and to be charged until Winter 2025 (inclusive), with the understanding that a majority 'no' vote would result in the continuation of the current fee until Winter 2021?

Appendix A

1. Food Handling and Sales Permit

The current fee for a Food Handling and Sales Permit is \$25. The SSMU has also assembled a Service Kit which includes Gloves, Hairnets, Signage, and Surface Cleaner (sanitizer) at a cost of \$5. Should this fee pass, these would be free of charge for student groups.

Example 1 (Without Club Fund Fee Increase) - Club Expense for Samosa Sale including Permit Fee and Service Kit

3 samosa sales per semester (200 samosas per sale)

Expenses for Samosas: \$100

Expenses for Food Handling and Sales Permit and Service Kit: \$30

Sales (based of 1 for \$1, 3 for \$2): ~\$153

Total Revenue per sale: \$23 Revenue per semester: \$69

Example 2 (With the Club Fund Fee Increase) - Club Expenses for Samosa Sale with Permit Fee and Service Kit subsidized with proposed fee increase


3 samosa sales per semester (200 samosas per sale)

Expenses for Samosas: \$100

Sales (based of 1 for \$1 and 3 for \$2): \$153

Total Revenue: \$53

Revenue per semester: \$159



Example 3 (Without the Club Fund Fee Increase) - Increased Price of Samosa Sales with Permit Fee and Service Kit cost

(200 samosas)

Expenses for Samosas: \$100

Expenses for Food Handling and Sales Permit and Service Kit: \$30

Revenue **without** Sales Permit Fee and Service Kit cost (at 1 for \$1 and 3 for \$2): \$59

Revenue with Sales Permit Fee and Service Kit cost (at 1 for \$1 and 3 for \$2): \$23

Potential Price Increase to Make up for Lost Revenue: 1 for \$1.20 and 3 for \$2.50 (revenue: ~\$59)

Equation used: Revenue = 2(33a + 66b) - \$130

where a = cost of 1 samosa when buying 1 and b = cost of 1 samosa when buying 3

Assuming that 33 samosas will be bought for 1 for \$1 and 66 samosas will be bought for 3 for \$2 per box of 100 samosas

Motion Regarding Adoption of the SSMU Francisation Plan 2020-01-30


As a corporation in the Province of Québec registered with the *Registraire des entreprises*, the SSMU is required to comply with the Charter and its associated Regulations. A key component of the Regulations is that corporate documents, which include governance documents and promotional materials, must be made available in French with at least the same standard of accessibility as those in English or another language (art. 52).

In order to strengthen the SSMU's compliance with the Charter and the Regulations, a Plan is needed to ensure that the SSMU has an articulated plan for the francisation of its corporate documents.

This issue has previously been addressed by the Legislative Council in the 2018-2019 year when the Vice-President (Internal Affairs) was mandated to carry out the translation of the SSMU's corporate documents. Given that Legislative Council resolutions expire at the end of the year in which they were adopted, a Plan is required to ensure the long-term viability of this work.

Do you agree to the increase of the non-opt-outable SSMU Membership Fee, payable by all undergraduate students who are members of the SSMU of \$2.59 per student per semester in addition to the regular increase of the fee limited to indexation for inflation according to the Bank of Canada CPI (Consumer Price Index) for the province of Quebec (using the rate at the end of March) starting in Fall 2020 with the understanding that a majority "no" vote would result in the regular increase of the fee limited to indexation?

11. Creation of an Affordable Student Housing Fee

Motion Regarding Affordable Student Housing Plan 2020-02-13

L'Unité de travail pour l'implantation de logement étudiant (UTILE) is a non-profit service provider that specializes in building design and in fundraising for student housing. Since 2014, they have consulted with the student body through associations and direct surveys, studying the conditions necessary to create affordable housing that would be suitable to a McGill population.

The need for secure, affordable housing for students is particularly high. Vacancy rates are below 3% in areas populated by McGill students, giving landlords an enormous amount of negotiating power when negotiating leases and lease changes. This means students are overcharged and otherwise exploited.

This fee will go toward financing a student housing project with UTILE, with a target of 300 units and other qualities attached in a draft term sheet. Rents from the apartment will first be used to pay off the mortgage, and then put into a fund for a future project. Every apartment building UTILE builds actually makes it easier for the next one to be built, and so this fee will ensure an infrastructure for future housing projects.

Do you agree to the creation of a non-opt-outable SSMU UTILE fee of \$6.53 reserved for the promotion of affordable student housing through construction of housing units and promotion of housing information, for all full and part-time SSMU members, to start in Fall 2020 and to be charged until Winter 2025 (inclusive), with the understanding that a majority "no" vote would result in the non-existence of SSMU Affordable Student Housing?
