## CLUB DELEGATES ELECTION GUIDLINES

1. Delegates may nominate themselves;
2. All nominations must be seconded;
3. All candidates mau make a presentation lasting no longer that 2 minutes;
4. There shall be a 10 minutes recess following candidate's presentations prior to voting;
5. Nominations or delegates absent will not be permitted;
6. Voting by proxy will not be permitted;
7. Voting shall be by secret ballot.



## CLUB REPRESENTATIVE'S DUTIES



The following are a few considerations and ideas that candidates should bear in mind prior to accepting nomination for club rep. None of these, however, is set in stone - yet!

- Remember that you represent clubs and not your personal opinion on Council;
- Inform yourself as to what generally concerns the clubs that you represent;
- Commit to being on top of all matters and trouble shoot when necessary. Both of these areas take a bit of time;
- Meet with the clubs on a regular basis;
- Produce newsletters to keep clubs and the Society up-to-date;
- Prepare to attend Student Council meetings regularly;
- Sit on a least one committee of Council;
- Meet with the V.P. Internal to discuss any problems or policies;
- Be an active, high profile club representative and councillor.

Present Club Representatives recommend that you do not have too much on your plate, for example being the President or executive member of any group. This position demands extensive time commitment as well as a high energy level. Basically, the more you invest, the greater the return.

Subj: Referenda Results: SSMU Fees

Dear Dean Gopnik,

This memo is to confirm the results of the 1993 SSMU referenda. The questions presented to students were as follows:

Question 5: Do you approve that the Students' Society fee be increased by \$0.50 per semester for the Walksafe Network?

Result: Yes- 86.4%

Question 7: Do you agree that the Student Prescription and Accident Insurance Plan fee be eliminated from the Society fee for international students since these students must obtain an equivalent insurance through Student Services? This would result in a separate Students' Society fee for international students.

Result: Yes- 68.3%

I would like to request that the University 1) increase the SSMU fee by \$0.50 per semester, and 2) reset the SSMU fee for international students at the current fee minus the Health Plan effective September 1993.


